Based on our review conducted as above and the representation received with respect to the promoters and promoter group shareholding which has been taken as per the said representation provided to us by the management, we report that, subject to certain reconciliations/ confirmations/ adjustments which are carried out at the year end (the impact of which has not been ascertained) and subject to our comments in Para 3 above, nothing has come to our attention that causes us to believe that the accompanying statement of unaudited financial results prepared in accordance with applicable accounting standards and other recognised accounting practices and policies has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement including the manner in which it is to be disclosed, or that it contains any material misstatement.
